- IASA was founded 1970, first President:
   Donald Leavitt, Library of Congress, United States
- Technical Committee Founded: 1975 by Dietrich Schueller, Austrian Academy of Sciences
- He was chair of the TC until 2001
- Followed by our current Chair, Lars Gaustad National Library of Norway


- 1978: Standard for the tape exchange between archives. IASA Technical committee report.
- Not an official standard, but the first TC publication







# TC 06 background and context

Carl Fleischhauer

#### IASA-TC 06 Guidelines for the Preservation of Video Recordings

Archives hold original video recordings in a range of types, from media-dependent, carrierabased analogue videotapes to computer-file-based digital recordings. The appropriate preservation treatments for this array reflect the variation in the source recordings. For analogue videotapes, for example, *digitisation* is called for. Meanwhile, examples of digital file-based recording may require rewrapping into a fresh file "wrapper" or a combination of digital *transcoding* and *rewrapping*.

When complete, IASA-TC 06 will cover the full range of topics in the preceding paragraph, as well as providing advice on shooting ethnographic, documentary, and oral history video footage in a manner that maximizes its "preserve-ability".

IASA-TC 06 is being disseminated in two editions:

Edition I: preservation of video recordings on conventional carriers. For the most part, this means the digitization of analogue videotapes, but it also encompasses the transfer of content from some types of digital videotapes. 2018: disseminated for comment; 2019: revised version.


Edition II: preservation of digital-file-based video formats and digital recordings on videotape.

Additional information will guide the production of new recordings in preservable formats. Work in progress.










## Collaborative Editing Platforms Research

- Researched 31 platforms
- Collaborative editing approaches
  - Markdown
  - Self-hosted
  - WYSIWYG (multinational platform)
- Requirements for collaborative editing platforms (collected during the TC 06 workshop) read/write access, multiple contributors in parallel, multiple computer platforms, low-bar to entry, content needs to remain indefinitely, WYSIWYG, browser-based editor, cloud-based, free/at a cost, ethical, accessible from China
- Priorities
  - Manages read/write permissions
  - Ease of use
  - Web-based service


